Hospital Indemnity, Precision Care™ Cancer, Recover Cash® Short-Term Nursing Home Care Indemnity, GTL Life Select, Home Care Secure and Short-Term Home Health Care applications can be combined in order to meet the application minimum and accumulate during the Fourth Quarter. GTL will pay the per application bonus on qualifying business on applications submitted, signed and dated between October 1 and December 31, 2023. All applications must be received at the home office no later than 1/10/24 and must be effective, issued, paid and inforce on 1/31/2024 to qualify. Business written on self or immediate family members will not count toward qualifying production. Premiums under \$15 monthly EFT or \$180 annually do not count toward qualifying production. Qualifiers must maintain a minimum persistency on qualifying business.
