2026 Annual Certification Requirements

UnitedHealthcare Certification Requirements

To solicit, present or sell any UnitedHealthcare Medicare products (*may include plans branded UnitedHealthcare, AARP, Erickson, Peoples Health, Preferred Care Networks or Preferred Care Partners*), you must be **licensed** and **appointed** (as required by the state) in the state in which the consumer resides and **certified** in the product(s) you are presenting to and/or enrolling the consumer. To become certified for the plan year, you must successfully pass all the Base Level assessments and the Next Level assessments for the product(s) you wish to sell or events you wish to conduct.

NOTE: While you may proceed directly to each assessment without reviewing the certification content, it is strongly recommended that you review the Certification Study Guide before attempting the assessment.



A 4-step summary of how to certify is as follows:

Step 1: Review any *recommended* courses needed:

- The STUDY GUIDE which contains the content needed to pass the assessments
- The **DECISION TREE** to help you determine which courses to take
- The **USER GUIDE** (you are reviewing now) with detailed step-by-step certification instructions
- The PATH COMPARISON VIDEO for a visual demonstration of everything you need to complete

Step 2: Complete the required courses

- Review the WHAT'S NEW document which summarizes key topics that are new for the year
- Review and sign the **PLEDGE OF COMPLIANCE**

Step 3: Complete all 3 REQUIRED Base Level Assessments

- A passing score of 85% or higher within 6 attempts (70% for AARP) is required
- Failing any Base Level assessment will block access to any other assessments, and you will not be able to market or sell any UnitedHealthcare Medicare plans for the plan year.
- Base Level assessments must be taken in order:1) Medicare Basics,* 2) Ethics & Compliance, 3) AARP

* Medicare Basics includes credit for Medicare Advantage Plans (non-SNP), Prescription Drug Plans, Medicare Supplement Insurance Plans and Standalone Dental, Vision and Hearing.

Step 4: Complete any Next Level Modules and/or Assessments

- Events Basics module completion is required to conduct any marketing/sales events
- Dual Eligible and Chronic Condition Special Needs Plans (D-SNP/C-SNP) require a passing score of 85% or higher within 6 attempts
- You may also be invited to sell other plans. These will appear on your Home Page in Learning Lab if you have been invited.

 - Massachusetts Senior Care Options
 - Massachusetts One Care

AHIP Certification Instructions

We are pleased to once again accept the AHIP Medicare + Fraud, Waste and Abuse Training from American's Health Insurance Plans. Agents choosing to pursue AHIP via UnitedHealthcare are eligible to receive a \$50 discount by using our custom link in Learning Lab.

Per policy, agents choosing to certify via AHIP must obtain a minimum score of 90% within six attempts. Each purchase consists of three attempts (UnitedHealthcare only acknowledges the initial two purchases).

All agents are required to review the **What's New** document and sign the **Pledge of Compliance**. Agents certifying via the AHIP path must transfer a passing AHIP score (via our custom link) and then complete the remaining **Base Level** certification assessments: Ethics & Compliance and AARP. Passing all three will certify you to sell MA (non-SNP) Plans, Prescription Drug Plans (PDP), Medicare Supplement Plans, and Standalone Dental, Vision and Hearing Plans. (*AHIP Certification satisfies the requirement for the UnitedHealthcare Medicare Basics Assessment.*)

REMINDER: For agents choosing to complete the 2026 AHIP, either directly from the AHIP website or through another carrier, you are still required to follow the below directions to transmit your results to UnitedHealthcare and receive credit for the equivalents. The UnitedHealthcare discount will be forfeited if you choose to certify directly from the AHIP website or through another carrier.

NABIP Certification Instructions

We are pleased to offer another third-party certification program as a way to earn credit for the UnitedHealthcare Medicare Basics Assessment with a passing score from the National Association of Benefits and Insurance Professionals (NABIP).

Per policy, agents choosing to certify via NABIP must obtain a minimum score of 85% within six attempts. Each purchase consists of six attempts.

All agents are required to review the **What's New** document and sign the **Pledge of Compliance**. Agents certifying via the NABIP path must transfer a passing NABIP score (via our custom link) and then complete the remaining **Base Level** certification assessments: Ethics & Compliance and AARP. Passing all three will certify you to sell MA (non-SNP), Prescription Drug Plans (PDP), Medicare Supplement Plans, and Standalone Dental, Vision and Hearing Plans. (*NABIP Certification satisfies the requirement for the UnitedHealthcare Medicare Basics Assessment.*)

REMINDER: For agents who purchase the 2026 NABIP training through the UnitedHealthcare link, the completion will be reported to UnitedHealthcare upon passing the final exam. However, agents who choose to purchase and complete their 2026 NABIP training outside of UnitedHealthcare (e.g., either directly from the NABIP website or another carrier) will need to contact the Producer Help Desk (PHD) to submit a request to transfer their results.
