

# Aetna Quote & Enroll New Signature Process



Changes are coming to the E-App Signature method! Starting July 7th we will offer an authorization code signature option for E-Apps in our Aetna Quote & Enroll Tool. **This will replace the security question signature option.** The following quick reference guide will explain the changes that are coming.

From July 7th to July 20th, both the security questions and the Authorization Code will be available. On July 20th the security questions will be retired and replaced entirely by the new Authorization Code method.

To send a text authorization code agents will need to make certain the 'Text' button is filled in.

To send an email agent's will need to make certain the 'email' button is filled in.

Once text or email is selected the field below will pre-populate with the applicant's preferred contact method.

This can be changed, but it CANNOT be changed to the agent's phone number or email.

After you have verified the correct contact information you can send the authorization code. The code will expire in **24 hours**.

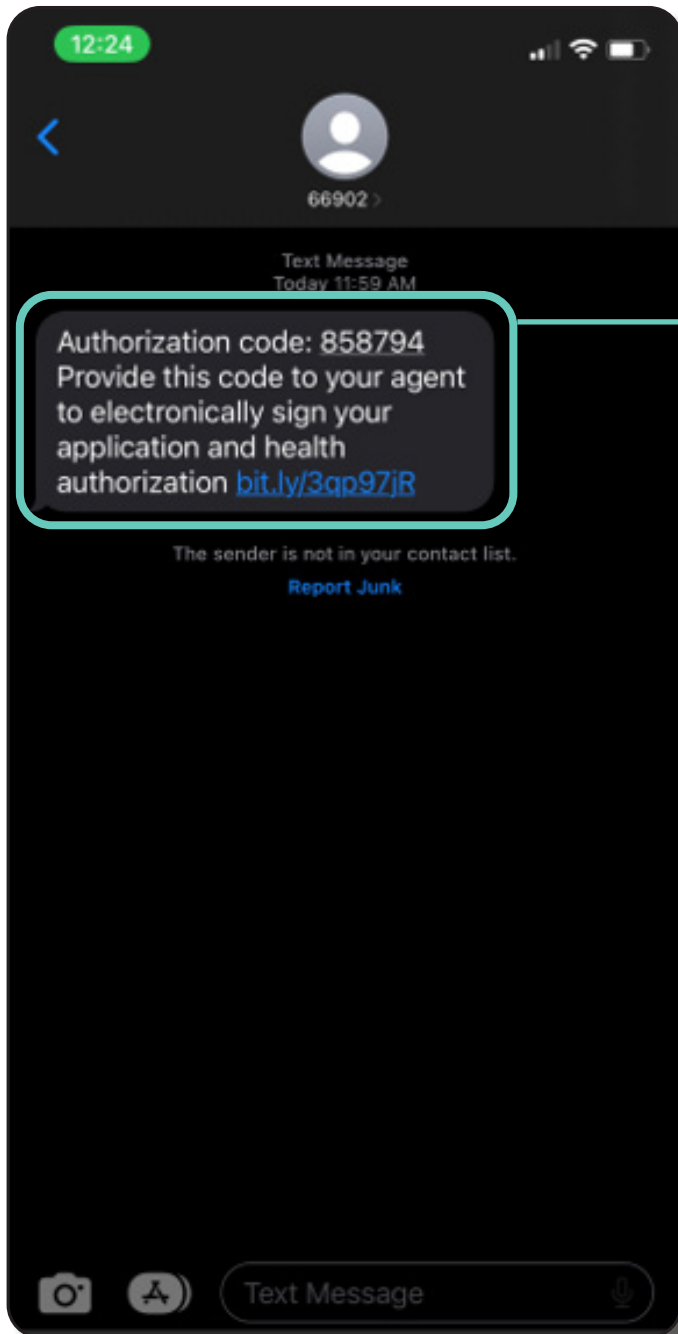
If the applicant changes their mind on how they would like to be contacted agents can do so.

The code can be resent up to 5 times.

The agent does not need to stay on this page until they receive the code. Applications will be saved in the 'My Cases' section of the AQE tool so agents can safely navigate away and return to the application.

Agents can submit the code provided by the applicant and select the 'Verify Authorization Code.'

If the code is correct the agent will receive a message stating the code was correct.

If the code is incorrect the agent will be prompted to try again.

Agents will then be prompted to agree to the terms and conditions.

Once the codes have been verified agents will be able to submit the signature for the applicants.
