Starting July 7th we will offer an authorization code signature option for E-Apps in our Aetna Quote & Enroll Tool. **This will replace the security question signature option.** The following quick reference guide will explain the changes that are coming.

From July 7th to July 20th, both the security questions and the Authorization Code will be available. On July 20th the security questions will be retired and replaced entirely by the new Authorization Code method.




The agent does not need to stay on this page until they receive the code. Applications will be saved in the 'My Cases' section of the AQE tool so agents can safely navigate away and return to the application.
